PUBLIC COMMENTS: Chairman Cochrane advised that this was the time the Board of Commissioners would receive comments from the citizens regarding any matter they desired to address.

Being no one wishing to speak, Chairman Cochrane declared the public comments section closed.

UPON MOTION by Commissioner Craig, the Board voted unanimously to approve the rezoning request for CUP #218.

Zoning Map Amendment No. 456 – Russell Dellinger, applicant: Randy Hawkins, Zoning Administrator, stated that the Planning Board voted 7 - 0 to recommend approval.

UPON MOTION by Commissioner Funderburk, the Board voted unanimously to approve Zoning Map Amendment # 456 – Russell Dellinger, applicant, based on the recommendation of the Planning Board.

Budget Public Hearing: Chairman Cochrane opened the budget public hearing.

Christina Arlow, parent of a Lincolnton High School student, thanked the board for their choices in the budget and for giving education a high priority.

Robert Hamilton stated that he realized the tough decisions the Board has to make and thanked the Board for supporting the schools.

David Baxter thanked the Board for their work on the budget. He also commented on the need for economic growth and industry to support taxes.

Dr. Jim Watson, Superintendent of Schools, commended the Board for making education a top priority in a tough budget year.

Fred Jarrett, School Board member, stated that he firmly supports education in this county and the funding that has been given in the past. He stated that the School Board members as well as Commissioner Mitchem and Anderson demonstrated fiscal responsibility in the budget process. The total request was a \$1,248,000 increase, the majority of which was to open 2 new schools. Mr. Jarrett presented 2 budget related items that need to be addressed: the fund balance challenge and the funding of the Naval ROTC Program at West Lincoln High School (\$61,000). The ROTC Program has been approved for the upcoming school year.

Terry Jones spoke in favor of Lincoln County Schools and challenged the Board to look forward to next year and move schools forward, not backwards in the years ahead.

Tim Carswell thanked the Board for the effort put into this budget. He stated that the budget and economy are tough right now, but education is very important.

Being no additional speakers, Chairman Cochrane declared the public hearing closed. He stated that the Commissioners are committed to education, but have a delicate balance between the tax rate and funding the school's needs. He encouraged everyone to shop in Lincoln County to help the tax rate.

Commissioner Anderson stated that members of the School Board have been most gracious. They have met long and hard, finding answers they had to find. He stated that he and Commissioner Mitchem learned a lot during the meetings.

Commissioner Mitchem commended Dr. Watson, the School Board, and staff for finding difficult answers to tough questions.

UPON MOTION by Commissioner Funderburk, the Board voted unanimously to adopt the Budget Ordinance.

There is hereby levied a unified tax at the rate of 62.0 cents per one hundred dollars (\$100) valuation of property listed for taxes as of January 1, 2003, for the purpose of raising the revenue listed as "Current Year's Property Taxes" in the General Fund in Section 2, of this Ordinance.

This rate of tax is based on an estimated total valuation of property for the purpose of taxation of \$4,672,746,847 and an estimated collection rate of 96.65 percent. The estimated rate of collection is based on the fiscal 2001-02 collection rate of 96.65 percent.

Section 10. There is appropriated to the special fire districts from the proceeds of this tax the amounts shown under the appropriation column, for use by the special fire districts in such manner and for such expenditures as is permitted by law from the proceeds of this tax. In the event the actual net proceeds from the tax levies exceed or fall short of the appropriated amounts, the actual net proceeds from the tax shall constitute the appropriation from the tax levy.

Lincoln County will continue to serve as collection agent for the City of Lincolnton for the collection of property taxes, as long as this is mutually agreeable between Lincolnton and Lincoln County. Lincoln County shall receive a three percent (3%) collection fee (1 1/2% fee for motor vehicles, for this service, plus unusual expenses as agreed by both parties.

Section 11. On October 8, 1990, the Board of County Commissioners adopted "An Ordinance for Lincoln County with respect to imposing a monthly enhanced 911 charge." As stated in this Ordinance, adjustments in the amount of the monthly charge for recurring costs may be made at any time by the Lincoln County Board of Commissioners. It has been determined by the Board of Commissioners that this monthly charge shall remain at the current charge of \$1.00 per month. These funds are needed in order to meet the expenses associated with the enhanced 911 system.

Therefore, effective August 1, 2003 the monthly charge is one dollar (\$1.00) for each exchange access facility subscribed to by a telephone subscriber whose exchange access line or lines are located in Lincoln County which are in the area served by the Enhanced 911 Service. The above monthly charge shall remain in effect until changed by the Lincoln County Board of Commissioners.

Section 12. On June 29, 1992, the Board of County Commissioners adopted "Ordinance for Availability and Use Fees for Solid Waste Disposal Facilities Lincoln County, North Carolina." As stated in the ordinance the fees for availability fees shall remain in effect until amended. The Landfill Availability Fees were last revised on June 28, 1995 at such time they were increased to \$69 per unit. For the fiscal year 2003-04 the availability fee shall remain at the \$69 per unit rate.

Section 13 This Budget Ordinance, effective July 1, 2003 authorizes the mileage reimbursement rate of 34 cents per mile where applicable.

Section 14. The funds that are used in this Budget Ordinance to fund certain elements in the Landfill and Water Works operations are non-property tax funds.

Section 15. The County Manager is hereby authorized to transfer appropriations within a fund as contained herein under the following conditions:

- a. He may transfer amounts among objects of expenditure within a department.

- b. He may transfer amounts up to \$20,000 between departments of the same fund.
- c. He may not transfer any amounts between funds nor from the contingency or from any capital reserve appropriations.

Section 16. The County Manager is hereby authorized to execute contractual documents under the following conditions:

- a. He may execute contracts for construction, repair projects or design services requiring the estimated expenditure of less than \$20,000.
- b. He may execute contracts for: (1) purchases of apparatus, supplies, and materials, or equipment which are within budgeted appropriations, (2) leases of personal property for a duration of one year or less and within budgeted appropriations, and (3) services which are within budgeted appropriations.
- c. He may execute grant agreements to or from public and non-profit organizations, which are within, budgeted appropriations, unless a grantor organization requires execution by the Board of Commissioners.
- d. He may execute contracts, as the lessor or lessee or real property, which are of one-year duration or less, if funds therefore are within budgeted appropriations.

Section 16. Copies of this Budget Ordinance shall be furnished to the County Manager, Clerk to the Board of Commissioners, Finance Director and the Tax Administrator for direction in carrying out their duties.

EMS Systems Plan: Ron Rombs stated that a little over a year ago, General Assembly put together several bills which mandate the preparation and submission of a comprehensive written plan as to how emergency medical services will be carried out in Lincoln County. He reviewed the Plan with the Board.

UPON MOTION by Commissioner Craig, the Board voted unanimously to accept the EMS Systems Plan.

Public Hearing – Ordinance Regulating Ambulance Service and Granting of Franchise to Ambulance Operators and Other Pre-hospital Medical Care

Providers: Ron Rombs presented the Ordinance Regulating Ambulance Service and Granting of Franchise to Ambulance Operators and Other Pre-hospital Medical Care. Any organization providing pre-hospital care or rescue in Lincoln County would fall under this ordinance. This Ordinance would require additional liability insurance. The Systems Plan does require that all education and certification requirements are met by January, 2006 and all technical certifications by June 1, 2004.

Commissioner Craig asked if all fire and rescue squads are aware of the changes in the document.

Ron Rombs stated that they are not to the full extent of everything involved, but they have been meeting with the fire departments over the last few months. He stated that there was opposition from the fire departments and rescue squads.

There was a discussion about the liability issue with not having any standards. Jeff Taylor stated that there is a state-wide standard. We are allowing some groups here to be part of the system and not following the standard. This could be a liability risk since there is a standard out there that is not being followed.

Dr. Ingrid Kish stated that there has to be standards. She stated that anyone initiating or delivering medical care falls under her medical license. She stated that if they do not follow the Ordinance, they do not operate, and she'll have the power to dismiss them.

Chairman Cochrane opened the public hearing for the Ordinance. Being no one wishing to speak, Chairman Cochrane declared the public hearing closed.

Lincoln County EMS Rate Increase Proposal: Ron Rombs presented the proposed rate increase proposal. After review of the annual Medicaid Cost Report, it is necessary to adjust the rates charged for care rendered to the patients of Lincoln County Emergency Medical Services. The fee increase is due to increased cost of providing services.
