**Public Comments:** Chairman Cochrane advised that this was the time the Board of Commissioners would receive comments from the citizens regarding any matter they desired to address.

**Sylvia Holmes** stated that she's here tonight because she wanted to be here for the Leases on the Little Creek and Beatty's Ford Access areas. She spoke about recreation and open space.

**Maggie Dollar and Susan Ledford** gave the Board an update on the wreck that happened last week on Highway 27 East. Ms. Dollar stated that they are in the process of testing wells in the area.

Commissioner Craig stated that he received a complaint from a lady on Hill Road that was upset that she was not notified of the accident. He stated that the lady woke up after the wreck choking on gas fumes. Commissioner Craig stated that he believes that in the future, there should be a policy established to go door to door telling people about dangers involved with the situation.

WHEREAS, in 1998 Mecklenburg County Commissioner Tom Bush launched an initiative to conduct a Regional Environmental Summit among representatives of Mecklenburg, Lincoln, Anson, Cabarrus, Catawba, Regional Environmental Summit among representatives of Mecklenburg, Lincoln, Anson, Cabarrus, Catawba, Regional Environmental Summit among representatives of Mecklenburg, Lincoln, Anson, Cabarrus, Catawba, Cleveland, Gaston, Iredell, Rowan, Stanly, and Union Counties in North Carolina and Lancaster and York Counties in South Carolina to identify and catalyze action on key environmental issues affecting the environment in the Central Carolinas region; and

WHEREAS, the mission of the Regional Environmental Summit was to develop an environmental vision for the region, seek common ground among the various forces which impact the environment, and seek agreement on possible ways to balance the need for a wholesome environment with the inevitable growth in the region; and

WHEREAS, representatives of government, business, and environmental interests in the various counties, including Lincoln County, participated in the summit; and

WHEREAS, the issues raised at the summit with respect to the future of water and air quality, land use, and open space in the region, as well as in Lincoln County, have highlighted the need for the creation of a government-sanctioned body to formalize recommendations affecting these matters; and

WHEREAS, the creation of such a body would facilitate applications for grants that might be available to assist Lincoln County officials with the issues referred to herein; and

WHEREAS, the Lincoln County Board of Commissioners recognizes the critical need for proper management of environmental issues as Lincoln County faces growth in the coming years;

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED:

1. That the Lincoln County Board of Commissioners creates a committee to be known and designated as the "Lincoln Natural Resources Committee."
2. That the Committee shall consist of not less than 25 members to be appointed by the Lincoln County Board of Commissioners at a later date.
3. That the initial members of the Committee shall serve terms as follows: nine members shall be appointed to serve terms of three years expiring on June 30, 2004; eight members shall be appointed to serve terms of two years expiring on June 30, 2003; and eight members shall be appointed to serve terms of one year expiring on June 30, 2002. Subsequent appointments shall be for terms of three years and shall run from July 1 until June 30 of the third year following the appointment.
4. That the Committee shall conduct itself in accordance with the bylaws attached hereto as Exhibit A and incorporated herein by reference and such amendments to the bylaws as may be made from time to time.

Chairman Cochrane called for a five minute recess.  
Chairman Cochrane called the meeting back to order.

**Beattys Ford and Little Creek Lease Agreements – Erma Deen Hoyle:** Erma Deen Hoyle presented the lease agreements for Beattys Ford and Little Creek lake access areas.

**UPON MOTION** by Commissioner Craig, the Board voted unanimously to approve the lease subject to the completion of the following terms:

1. 50 year term
2. limitation being negotiated on the cost liability of the county
3. authorizing Chairman to sign
4. have survey done
5. allow expansion for Lincoln County Lifesaving Crew.

**NC Forest Service – Mountain Island Educational State Forest – Laura Sutton:**

Laura Sutton presented information on the Mountain Island Educational State Forest and asked for the Board's support in getting the educational state forest started. She stated that Senate Bill 216 was introduced this year to fund the forest. The start up costs for this forest will be around \$3.2 million.

**Comments from Sheriff Barbara Pickens:** Sheriff Pickens requested the Board's permission to start a study on reverse 911, which is a system that could be used to notify citizens of situations such as the one with the tanker accident. This system would use our current telephone system.

Sheriff Pickens stated that they use an old bus as the mobile command post for emergency situations. She stated that this command post does not have a bathroom. She asked the Commissioners to visit the command post and take a look at it.

Sheriff Pickens stated that Lincoln County is being offered a \$20,117.00 grant that will require a 10% match. This is the third year the county has applied and the last two grants were used to provide security cameras for East and West Lincoln High Schools. This grant would be used for a security camera at Lincolnton High School.

**UPON MOTION** by Commissioner Saine, the Board voted unanimously to approve the application for the grant and obligate the 10% match.

Sheriff Pickens requested permission to allow the Sheriff of Wilkes County to take and use the old bunks from the old jail facility.

**UPON MOTION** by Commissioner Choate, the Board voted unanimously to approve allowing the Sheriff of Wilkes County to get the old bunks.

**Centralina Proposal – Bill Duston:** Bill Duston from Centralina submitted a proposal for Centralina to provide interim Zoning Administrator staff services to Lincoln County. He proposed having Nadine Bennett, a Centralina staff planner, in Lincoln County upwards of sixteen hours per week for up to ten weeks. Ms. Bennett could start the first of August. The cost of this project is estimated to be \$7840. This price includes the use of two blocks of membership hours from the County's FY 2001-2002 allocation. The county will only be charged for the actual amount of time spent on this project.

**UPON MOTION** by Commissioner Saine, the Board voted unanimously to accept the proposal from Centralina COG.

There was a brief discussion with Mr. Duston concerning moratoriums and availability fees.

**Selection of Architect for EMS and Social Services:** Stan Kiser, County Manager, presented recommendations from the committees for the selection of the architects for the DSS and EMS buildings.

He stated that the EMS selection committee consisted of the County Manager, the Finance Director, Director of EMS, and Commissioner Tom Anderson. The DSS committee included the County Manager, the Finance Director, DSS Director, and Commissioner Tom Anderson.

For the EMS facility, of the 9 architect firms which submitted RFQ's, four were selected for interviews. The firms, listed in order of preference, are based upon presentation, firm size, and experience with public safety facilities. They are as follows:

1. Stewart-Cooper-Newell Architects
2. FreemanWhite
3. Williams Design.

Commissioner Craig stated that he feels like Dennis Williams has done an excellent job on all the facilities he has helped construct and reconstruct. He stated that his preference would be to use Williams Design.

Commissioner Anderson stated that all of these firms are fine firms and capable of doing the project. He stated that the task of the committees was not to select an architect who could do the project, but to find an architect with technical expertise in the field. He stated that the number one ranked firms were the ones that seemed to the agency representative to have the most targeted experience.

**A MOTION** by Commissioner Anderson to accept the rankings and authorize the County Manager to open negotiations with Stewart-Cooper-Newell Architects, the number one firm.

Mr. Kiser stated that for the DSS facility, eleven firms submitted RFQs. Of these eleven, five firms were selected for interviews. The top three firms are listed below:

3. Stewart-Cooper-Newell Architects



Chairman Cochrane stated that he has concern for this selection, because he knows what Williams Design has done for buildings that this Commission has approved and Gaston College. He stated that he knows what Williams Design has done with existing buildings. Chairman Cochrane stated that it is a different challenge to take an existing building and creating a nice functional building.

Commissioner Craig stated that he agrees 100%.

**UPON MOTION** by Commissioner Craig, the Board voted unanimously to reverse numbers 1 and 2, putting Williams Design as number one and Freeman White as number two, and authorizing the County Manager to negotiate with number one, coming back to the Board with a proposal.

**Purchase of Ambulances Under Piggy Back Method – Ron Rombs:** Ron Rombs stated that the Board approved the purchase of 2 ambulances for FY 2001-2002. He requested that Lincoln County use the piggyback method of purchasing these ambulances. The piggyback purchase would allow us to use the same formal bid as Floyd County, Virginia, which was the same contract used in November, 2000.

The purchase of the two 2001 model F-350 Ambulance in the amount of \$163,534 will be the same price contracted last year.

#### **RESOLUTION TO APPROVE WAIVER OF BIDDING REQUIREMENTS TO PURCHASE AMBULANCE**

WHEREAS, Lincoln County operates an emergency medical system to serve residents of Lincoln County; and

WHEREAS, in order to operate this emergency medical system efficiently, it is necessary to purchase ambulances and other associated equipment; and

WHEREAS, Lincoln County has a need to purchase two new ambulances to transport patients to medical care facilities; and

WHEREAS, within the 12 months previous to the date of this resolution, Floyd County, Virginia, a political subdivision of the state of Virginia, after receiving public, formal bids in a process substantially similar to that required Article 8 of Chapter 143 of the North Carolina General Statutes, approved the purchase of a new ambulance from Northwestern Emergency Vehicles of Jefferson, North Carolina, in the amount of \$81,767; and

WHEREAS, Northwestern Emergency Vehicles is willing to make available to Lincoln County the same pricing as the contract approved by Floyd County, Virginia, in the amount of \$81,767; and

WHEREAS, N. C. G. S. 143-129 allows a local government to “piggyback” on a previous contract that was awarded through the formal bid process after a notice of intent to make such award has been published; and

WHEREAS, such notice of intent was published in the *Lincoln Times-News* at least 10 days prior to the date of this resolution;

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED:

1. That it is in the best interest of Lincoln County to waive the requirements of Article 8 of Chapter 143 of the North Carolina General Statutes for the purchase of the ambulances on the terms outlined herein.

2. That the purchase of two ambulances from Northwestern Emergency Vehicles in the amount of \$163,534 is hereby approved as authorized by N. C. G. S. 143-129.

**WHEREAS,** this local option ½ cent sales tax could increase and provide a permanent, growing local revenue source; and

**WHEREAS,** the uncertainty of existing reimbursements would no longer be an issue with the local option ½ cent sales tax, as the funds would be guaranteed; and

**WHEREAS,** the Lincoln County Board of Commissioners, along with the North Carolina Association of County Commissioners believes this proposal presents a critical opportunity to secure a permanent, growing local revenue source in lieu of the frozen, vulnerable reimbursements.

**NOW, THEREFORE, BE IT RESOLVED** that the Lincoln County Board of Commissioners officially and respectfully requests that the General Assembly of the State of North Carolina support the local option ½ cent sales tax to replace the reimbursements for intangibles and inventory tax.
