RESOLUTION

That **WHEREAS**, the 1997 General Assembly enacted General Statute 47-30.2 requiring the Board of Commissioners of each county, by resolution, to designate by name one or more persons experienced in mapping of land records management as a Review Officer to review each map and plat required to be submitted for review before the map or plat is presented to the Register of Deeds for recording, and

WHEREAS, the Lincoln County Board of Commissioners believes and so find that Barry McKinnon is a person experienced in mapping of land records management in the spirit of the aforesaid statute, and

WHEREAS, to comply with General Statute 47-30.2, the Lincoln County Board of Commissioners enacts this Resolution:

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED, by the Lincoln County Board of Commissioners and its October 15, 2001 regular meeting as follows:

1. That Barry McKinnon be and is hereby appointed as a **REVIEW OFFICER** to review each map and plat required to be submitted for review before the map or plat is presented to the Register of Deeds for recording.
2. That the **REVIEW OFFICER** shall review expeditiously each map or plat required to be submitted to the officer before the map or plat is presented to the Register of Deeds for recording.
3. The **REVIEW OFFICER** shall certify the map or plat if it complies with all statutory requirements for recording, and affix his certification to the map.

4. This Resolution designating the aforesaid **REVIEW OFFICER** be recorded in the Office of the Register of Deeds for Lincoln County and indexed on the Grantor Index in the name of the **REVIEW OFFICER**.

The foregoing Resolution was unanimously passed by the Lincoln County Board of Commissioners and its regular October 15, 2001 meeting.

There was a discussion concerning Greene's Concert's request for sponsored group status or waived fees.

UPON MOTION by Commissioner Craig the Board voted unanimously to defer Greene's Concert's request for waived fees until November 19th so further information can be provided.

UPON MOTION by Commissioner Choate the Board voted unanimously to approve the Consent Agenda with the exception of Greene's Concerts.

PUBLIC COMMENTS: Chairman Cochrane advised that this was the time the Board of Commissioners would receive comments from the citizens regarding any matter they desired to address.

UPON MOTION by Commissioner Saine, the Board voted unanimously to accept the Holiday Schedule as presented.

Modified Light Duty: Emily Robinson presented the board with the Modified Light Duty policy. She stated it was necessary for Lincoln County to have something like this to bring employees back to work on light duty if they're able to.

Modified/Light Duty Policy

Due to either work related or non-work related accidents and or illnesses an employee may be able to perform one or more of the essential duties of his/her job on a temporary basis. The following policy outlines Lincoln County's procedure for allowing employees to perform their job duties temporarily on a modified or light duty basis.

Light or modified duty is defined as a change in an employees job duties, hours of work etc. caused by a medical condition as certified by an authorized health care provider that renders an employee unable to perform one or more of the essential duties of his/her regular position with the County. Only medically authorized and specifically defined duties will be considered by Lincoln County for light or modified duty.

Light or modified duty cannot be guaranteed in every instance and will only be granted when available.

Light or modified duty will not be considered for non-work related accidents or injuries. Only work related accidents and or injuries will be eligible for light or modified duty positions on a temporary basis.

Light or modified duty on a temporary basis will be considered for conditions lasting up to three (3) months. Any light or modified duty in excess of three (3) months duration will not be considered for light or modified duty, thus, the employee will be placed on workers' compensation leave and FMLA should the condition qualify.

In order for an employee to be considered for or modified duty, a written, signed authorization to work with the specific duties the employee can and cannot perform along with anticipation duration of the condition must be furnished to the Lincoln County Personnel Department by an authorized health care provider. Upon receipt of such authorization, the Personnel Department will seek to accommodate the employee's limitations, either by placing the employee in a modified or light duty version of his/her regular job or another position which meets the specific recommendations as specified by the authorized health care

provider. **Under no circumstances will a position be created to accommodate an employee's medical condition on a temporary basis.**

All hours worked while on light or modified duty will be counted as FMLA should the medical condition qualify as such.

Lincoln County reserves the right, at its expense, to require all employees on light or modified duty to be seen by a physician for medical evaluation at any time during the duration of the modified or light duty period. All employees on light or modified duty must furnish written medical authorization prior to their being allowed to return to regular duty.

UPON MOTION by Commissioner Saine, the Board voted unanimously to approve the Modified Light Duty plan effective October 16, 2001.

Website Status Update: Dante' Patterson gave the Board a presentation on the Website's update. He stated MIS has acquired the www addresses, hardware work is done, and they are working on the final portions of the software. He noted that a worker would be out of the office because of health issues. Also, some recent security concerns have come about. On a daily basis MIS has had to remediate security issues involving our mail servers and web servers. He mentioned the large workload MIS is having to cover and what little help they have.

Resolution for New Water Fees:

**RESOLUTION CONCERNING APPLICATION OF
NEW WATER AVAILABILITY (CAPACITY DEVELOPMENT) FEES**

WHEREAS, the Lincoln County Board of Commissioners is faced with the responsibility of paying for various improvements to the County's water system over the next few years; and

WHEREAS, the Board of Commissioners recognizes the inequities that would be caused by paying for such improvements out of the County's General Fund; and

WHEREAS, at its meeting on August 20, 2001, the Board voted to implement an increase in the availability (capacity development) fee for water service in Lincoln County; and

WHEREAS, the increased fees were made effective at the beginning of business on August 21, 2001; and

WHEREAS, the Board has recognized that the immediacy of the effective date on the increase has had an adverse impact on residential projects that were already under construction as of the effective date of the fee increase; and

WHEREAS, the Board has determined that the issuance of a building permit for residential construction prior to August 21, 2001, is an appropriate and equitable standard to use to determine which projects would qualify for such relief;

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED that:

1. Residential construction projects for which building permits were issued on or before the close of business on August 20, 2001, shall be allowed to be completed upon payment of the water availability (capacity development) fees as set in the fee structure that existed prior to August 21, 2001, on the following conditions:
 - A. An appropriate building permit for the project must have been issued on or before the close of business on August 20, 2001, and must have remained in effect at the close of business on said date. (Projects that had permits that lapsed prior to August 20, 2001, will not qualify for that relief granted herein.)
 - B. All such fees must be paid in full by the close of business on November 30, 2001. Any project for which all water availability (capacity development) fees have not been paid in full on or before such date will be subject to the new fee structure that was adopted on August 20, 2001.
 - C. The owners of such projects bear all risk of dishonor or nonpayment of funds; if fees are paid with a check that is dishonored, the owner will thereafter be subject to the new fee structure unless such dishonor is made good by payment in full with cash or certified check on or before the close of business on November 30, 2001.
2. Any party who received a residential building permit after August 20, 2001, and has paid the increased water availability (capacity development) fee shall be refunded the difference between the amount of such payment and the amount that would have been due under the fee structure that applied prior to August 21, 2001.
3. County staff is hereby directed to examine the records of residential building permits issued since the opening of business on August 21, 2001, to determine who has paid the increased water availability (capacity development) fees as of the date of this resolution and to make reasonable efforts to notify the recipients of such permits that they may receive funds pursuant to this resolution.
4. County staff is further directed to examine the records of residential building permits that were issued and in force of the close of business on August 20, 2001, and make reasonable efforts to notify the holders of such permits that

they may qualify to proceed with their projects based on the former fee schedule as long as they meet the conditions set forth in this resolution.

5. This resolution shall be effective immediately.

UPON MOTION by Commissioner Saine, the Board voted unanimously to adopt the Adoption/Fostering Proclamation.

Chairman Cochrane called for a short recess.

Chairman Cochrane called the meeting back to order.

Report on Septic Tank Repair: Maggie Dollar stated the Board may want to consider re-looking at the issue of repairing septic tanks, when the residence can be hooked onto public sewer if available, because it is a state law. The intent is to prevent any health problems that can result from sewage spills. She stated that the Board of Health did look into this issue in 1997 and the plumbing code did state that all systems must connect where sewer is available. The current county ordinance only addresses and allows new construction or non-repairable malfunctioning systems to connect. The ordinance does not require repairable existing systems to connect and this was the question to the Board of Health in 1997, if this was safe to the public health. She stated that the state changed some rules requiring all new systems have 100% repair space in case of the drain fills going bad.

Commissioner Craig asked Ms. Dollar if she had any idea how many repairs are made yearly and what kind of repairs are being made. He stated that some owners go to the extent of replacing the whole system and they have the capability of hooking onto the sewer system. He stated the Board should look into what is to be repaired or replaced.

Ms. Dollar stated she would look into it and find out.

Commissioner Anderson stated it would help the Board to know what the definition of repairing and replacing are to the Health Department.

Ms. Dollar said she would get that information for them.

Ms. Dollar updated the Board about the Septic Pumpers issue. The City of Lincolnton notified the Health Department that they would no longer be accepting septage from pumpers because of an upcoming two-year construction project of the plant. This has caught the Health Department off guard. They have since, talked about taking the septage to other counties where higher fees apply. She stated land application is one means of disposing septage from septage tanks, but in the past they've had problems with land operators not treating the land appropriately.

Resolution Concerning Use of Room Occupancy and Tourism Tax:

RESOLUTION CONCERNING USE
OF ROOM OCCUPANCY AND TOURISM TAX

WHEREAS, it has been recognized that additional resources were needed in the promotion of travel and tourism in Lincoln County.

WHEREAS, a growing number of counties in North Carolina are using room occupancy taxes from the rental of rooms, lodging or accommodations, in the promotion of travel and tourism.

WHEREAS, on July 24th 1993 the North Carolina General Assembly approved legislation enabling Lincoln County to begin charging a room occupancy tax.

WHEREAS, after holding the required public hearings, the Lincoln County Board of Commissioners enacted a resolution levying a room occupancy tax on August 23, 1993 to become effective October 1, 1993.

WHEREAS, the enabling legislation of this tax requires that at least two-thirds of the proceeds from this tax be used to promote travel and tourism. The legislation also allows that the remaining revenues be used for tourism related expenditures.

WHEREAS, on September 12, 1994 a resolution was approved designating the use of the proceeds for fiscal years 1993-94 and 1994-95.

WHEREAS, on October 20, 1997 a resolution was approved designating the use of the proceeds for fiscal years 1995-96, 1996-97 and 1997-98.

WHEREAS, on October 4, 1999 a resolution was approved designating the use of the proceeds for fiscal years 1998-99 and 1999-00.

WHEREAS, during fiscal year 2000-01 Lincoln County received \$52,334, and expects to receive during 2001-02 \$55,000 from the tax.

WHEREAS, during fiscal year 2000-01 Lincoln County incurred the following expenses to promote travel and tourism: Chamber of Commerce \$16,000 to advertise print and distribute information on Lincoln County; Main Street Program \$12,000; Historical Properties \$1,418; Historical Association \$26,000; Historical Coordinator \$46,087; and Battle of Ramsour Mill \$4,482; for a total of \$105,987.

WHEREAS, during the current fiscal year Lincoln County has budgeted the following to promote travel and tourism: Chamber of Commerce \$15,600; Main Street Program \$11,700; Historical Properties \$7,221; Historical Association \$25,350; Historical Coordinator \$43,187; and Battle of Ramsour Mill \$4,387 for a total of \$107,445.

THEREFORE BE IT RESOLVED, That the revenues from the Local Occupancy tax be used for the above outlined tourism related expenditures and to promote travel and tourism for fiscal years 2000-01, and 2001-02.

The DOT meeting will be at the Civic Center in Statesville on October 25, 2001 at 2:00 PM.

UPON MOTION by Commissioner Saine, the Board voted unanimously to establish Highways 16, 150, and 73 as priorities to present at the DOT meeting.
