REPORT ON SEWER DISTRICT ACTIVITIES – PUBLIC SERVICE DIRECTOR—JACK CHANDLER

Jack Chandler gave a brief overview of the District activities of the fiscal year. He presented the following information:

Month	New Customers	New Applications

November (To-date)	5	4

Mr. Chandler stated that the trend that is beginning is fewer customers and fewer applicants coming in. He commented that if this trend continues, it will be difficult to meet the fiscal goals set for the year.

Jack Chandler stated that in February, 1995 a projection was made that there would now be around 1900 monthly paying customers, which would have all paid the \$3000 connection fee. He stated that there are 443 actual customers paying a sewer bill on a monthly basis. He commented that not all of these customers have paid their \$3000 in full. He stated that there are approximately 192 applicants that are making payments each month on the \$3000 connection fee. He stated that there are around 171 applicants that are not making payments and have not paid their connection fee in full.

ADJOURN

Being no further business to come before the Board of Commissioners, the governing body of the East Lincoln County Water and Sewer District, Chairman McConnell entertained a motion to adjourn the meeting.
