The Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in Lincoln County and hereby publishes a Request for Proposals. The JCPC anticipates funds from the NC Dept. of Public Safety Juvenile Justice and Delinquency Prevention in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the state fiscal year 2026-2027 beginning on, or after, July 1, 2026. The use of these funds requires a local match in the amount specified above.

**Based on identified needed programs and possible gaps in the service continuum, the following checked program types will be considered for funding:**

Mentoring Services	Restitution/Community Service
Parent/Family Skill Building	Teen Court – including Sentencing and Responsive Circles
Interpersonal Skill Building	Individual/Group/ Mixed Counseling
Mediation/Conflict Resolution	Substance Abuse Counseling

**Proposed program services should target the following risk factors for delinquency or repeat delinquency:**

Services for low and moderate risk youth and youth with moderate to high needs; see domain concerns listed below.

**Proposed services should address the following concerns as reported in the Youth Assessment Screening Instrument (YASI) for court-involved youth:**

1. Peer Domain: Negative Peer Association
2. Individual Domain: Mental/Behavioral Health Needs; Youth Substance Use
3. Family Domain: Inadequate Parental Supervision
4. School Domain: School Conflict/Behavior Problems; Academic Failure

**Applicants are being sought that are able to address items below:**

1. Program services compatible with research that are shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services detect gang participation and divert individuals from gang participation.
5. Awareness of and sensitivity to Racial Ethnic Disparity that exists in the County.
6. Programs are encouraged to provide effective programming that includes restorative justice practices.

**Only local public agencies, 501(c)(3) non-profit corporations and local housing authorities can apply for funding.**
